BOOKING PROCEDURE:

A) Fill and send by post in original the "Application Form"

B) enclose the receipt of payment of the deposit - compulsory

(for bank account see inside Chap. I Art 9 of General Rules and Regulations or form A in the box "DEPOSIT")

AREA ALLOCATION

February 25th 2024 starting exhibiting areas allocation.

The "exhibiting proposal" is considered to be confirmed by the exhibitor at the payment of deposit as indicated in the Application Form.

DEADLINE FOR REGISTRATION September 15th, 2024

BALANCE DEADLINE

August 26th 2024 deadline for total balance payment (Chap. I Art 9 of General Rules & Regulations).

April 28th 2024

If the written cancellation reaches the Organizer no later than **April 28th 2024**, the penalty will be equal to an amount corresponding to the registration fee.

July 29th 2024

If the written cancellation reaches the Organizer **from April 29th 2024, and no later than July 29th 2024**, the penalty will be equal to an amount corresponding to the deposit as established in the signed exhibiting proposal.

July 30th 2024

If the cancellation reaches the Organizer from the date of **July 30th 2024**, the penalty will be equal to an amount corresponding to the entire balance due as established in the signed exhibiting proposal.
